

“Bully” Phillip Glover Goes Ballistic at School Board Meetings !!!– Video “doctored” !!?? Report and commentary by Robert A. Williams

The Office of Sheriff of Cleveland County is the highest elected office in the county. Political chatter is that retired Highway Patrolman Phillip Glover ran for the School Board to get some political experience before running for his goal of Sheriff at the first opportunity when current Sheriff Alan Norman decides to retire. Now School Board Chairman Phillip Glover’s experience on the School Board is mostly bad experience with citizens complaints coming in from all sides. Somebody forgot to tell Glover that he had to have a shred of common sense, keep CCS on the right track, to control his bad temper, be able to properly manage taxpayer’s money and show some respect for citizens. All of Glover’s major failures can be easily shown in just the past two meetings. The January 23, 2017 and February 13, 2017 meetings.

They selected the Holland and Hamrick Architects for this project when this firm has made major mistakes in recent projects. auditorium is acoustics, where the goal is to design an auditorium that would have excellent acoustics for a variety of purposes. Specifically orchestra, drama, lectures and presentations.

Glover and his board member buddies selected Holland and Hamrick while in the very auditorium in the old Shelby High School that Holland and Hamrick just renovated at a very high cost. Yet Glover and company would pawn this kind of poor workmanship off at Burns and Crest High Schools while patting themselves on the back. In these items, CCS Superintendent Stephen Fisher again falsely stated that the North Shelby School students would have "educational opportunities" by such close proximity to the James Love School. Fisher never-never mentions that James Love School has scored failing marks for several years and the State is about to take over James Love. Of course Fisher never admits that hooking North Shelby School to James Love School will allow James Love to be placed in a different category, saving CCS the embarrassment of actually being taken over by the State. no!! CCS and Glover don't want the beans spilled about that. Especially since Glover is up for election this year and the Sheriff's race will be later (Hopefully never for Glover). And, so much for the myth that Glover, Fisher and the Board cronies give a whit about the students at North Shelby or Burns or Crest.

Board member Danny Blanton had received an email from a knowledgeable person regarding the soil conditions on the James Love School property that were unacceptable for construction. Necessary soil remediation at James Love was estimated to cost plenty enough that the new North Shelby School Project should have never even been considered for the James Love School location. But Glover being Glover and Glover's cronies being Glover's cronies, they just blew it off. Like so what? Then I immediately went to the back of the room to the video equipment area to see whether or not the cameras had caught that last comment from Mr. Queen. This was strange and it was also illegal. The meeting was over, NC Law requires any such gathering of a majority of school board members to do their business in open session with minutes being taken. I watched a bit, then I remembered that any such of a meeting was also open to the public.

So, I walked back up front to hear what they were talking about. Knowing that I had the legal right to hear what they were talking about.

The huddle of school board members must of also known that I intended to hear what they were talking about because they broke up before I got close enough to hear and headed across the stage for the side Exit. The School Board meeting on February 13, 2017 starts off bad as no Christian Pastor had signed up for the Invocation. Danny Blanton, who was THE major force on the School Board supporting Prayer even made the comment that he wished the Shelby Star Reporter would write an article reminding Preachers to come out and Pray for the School Board. I would remind Christian Pastors that this is a new year and those that Delivered Prayers last year can now sign up for this years school board meeting Invocations.

The "Citizens Recognition" portion of the agenda came up early in the meeting. Citizens came up one after another with serious complaints about CCS. One woman stated her son had been punched, stabbed, hit in the head with a rock and a variety of bullying at school and CCS was punishing her son. Another parent stated a coach was trying to make his son quit the team because he had reported something wrong. Mr. Billy Scruggs again spoke about the CCS Board, especially Bully Glover and Jo Boggs, telling lies about why CCS school busses quit coming down his road to drop off his grandson, after coming down his road for over thirty years to pick up and drop off CCS students. Another lady, most likely a plant by CCS, spoke about how great it was that the new North Shelby School would be located at the failing James Love School because of the educational opportunities. And one other citizen spoke. Mr. Robert Queen, a State Registered Professional Civil Engineer specializing in building foundations stated that he wanted to clarify some items from an email he had provided to the CCS Board. Mr. Queen then described how the budget figures for the North Shelby School project had escalated from \$10 million to \$13.5 million without any public discussion from the CCS Board. That he had discovered even bigger problems with the foundation requirements for the new North Shelby School Project and thought the CCS Board ought to be made aware of it. Especially since it involved 105,000 cubic yards (7,500 big truckloads) of dirt that will have to be moved plus a large number of piers (sometimes called "pilings" that have to be "pile-driven" into the soil), all of which will add \$Millions more to the construction costs of the North Shelby School Project. Mr. Queen went into inspection costs and stated inspectors should only be paid for the inspections they do, not by a percentage of total costs. Mr. Queen started his conclusion by stating that the CCS Board needed to be asking more questions. That the CCS Board had not been told everything and were not asking enough questions to get to the "whole truth" of the

matter in order to be responsible to the taxpayers of Cleveland County. Mr. Queen reminded the CCS Board that they had never discussed in open session the so called "educational opportunities" of locating the North Shelby School at the James Love site and how that justified the additional costs. Mr. Queen told the CCS Board that they probably were not told the truth about the soil conditions at the construction site (although Mr. Queen had himself previously told the CCS Board about substandard soil conditions. Mr. Queen apparently was talking about the CCS Board not being told by their own people-apparently incompetent people or people who have been told to keep their mouths shut about problems, which represents a much deeper problem). Mr. Queen continued by saying the CCS Board probably were not told about unfair payments of somebody else's property taxes on property CCS bought (in addition to paying over market value for the property), the CCS Board hasn't been told the capacity of the new North Shelby School (a reminder of what the CCS Board did with the new Shelby Middle School-SMS was built for 800 students yet only 400 actually attend), then Mr. Queen stated the CCS Board probably had not been told they had already spent \$1.1 Million on the new North Shelby School project before they had even broken ground."

At this point Bully Phillip Glove goes ballistic again. As Mr. Queen had started his conclusion with "North Shelby Students deserve better than this," Bully Glover, obviously angry, calls out "Mr. Queen your time is up." Mr. Queen keeps on reading his last few words with Bully shouting that his time was up, you are out of order and pounding his gavel.

I was sitting up front and paying full attention to all of this. What I saw and heard was Bully's loud voice and Bully's loud banging that obscured Mr. Queens last few words. Bully appeared red faced and mad. When I requested this clip of the CCS video be copied for this article and looked at it myself, I immediately determined something was wrong with the video.

It appeared to me the video was edited to lower the volume of Bully Glover's outburst and much of Bully's gavel banging was edited out.

I was not surprised as Bully is up for election and he most likely would not want such an outburst to be made public. So, I went to the end of the video to see how that was captured. In real life there was a closed session at the end of the meeting and then the CCS Board comes back into session to announce if any actions were taken and to close the meeting. None of that is in the final CCS video that is on the Official CCS Website.

And they thought they were doing something great. Bully even broke out clapping about what a good job he and his cronies had done.
