

Injustice Rules at the Cleveland County Courthouse!!! 50-B Restraining Orders Abused by Scheming Women!!! Self Inflicted Bruises and Makeup Enhancements too easily Fool Kangaroo Court Judges!! Conspiracies ignored!! Report by Robert A. Williams

Editor's Note: In following up with my "Jury Duty" series of articles regarding the Jim Teddy Wrongful Death-Medical Malpractice Lawsuit trial I had some free time Monday Morning, July 16, 2018 and found myself doing some additional court-watching in the Domestic Violence Court at the Cleveland County Courthouse. A better description would be I was Court Watching in a "Kangaroo Court."

It was about 10:30 AM Monday Morning, July 16, 2018 when I walked into the Domestic Court at the Cleveland County Law Enforcement Center. The room was pretty full so I had to sit near the back, instead of right up front as I usually do. This made hearing cases a little more difficult than usual.

The trial that caught my attention started out as a "Probation Violation" where Mike Pruett (not his real name) was the defendant. Shelby Attorney David Teddy was Pruett's Attorney. If convicted, Pruett faced 300 days in jail.

I just happened to sit down behind Pruett's fishing buddy and his parents. Between the court testimony and being filled in by others, I pieced together this chain of events that stretched back months. I became instantly interested when some of the things I heard reminded me of other situations with other people. Situations where women, aided by others, would either give themselves self inflicted bruises or used makeup to create what might appear to be bruises or a black eye and then go swear out phony warrants and phony 50-B Restraining Orders against their husbands. One such situation may rear it's head during this political process leading up to the 2018 Election Day. People involved can be traced back to connections with Commissioner Eddie Holbrook as well as a Cleveland County School Board cover-up of a sexual offense. This one I was watching with my own eyes.

This is what I heard and saw.

Mike Pruett and his wife got into an argument. Pruett somehow was able to record his wife talking to her mother with the mother explaining how the daughter should hit herself to cause bruises and use makeup to enhance the bruises, then go to the magistrate and take out assault charges on Mike Pruett. Which the daughter did.

Mike Pruett goes to court without a lawyer, gets convicted and gets probation.

Later, Pruett and his wife get into another argument. The wife is the aggressor and blacks Mike Pruett's eye. The Sheriff's Department gets a call and dispatches deputies. The deputies arrive, inspect both Pruett and his wife and find no sign of injuries to the wife. The deputies also determine that the wife is the aggressor and make her leave the premises. All this gets written up in an incident report.

But the wife and the mama again cook up the same old story. The wife makes herself up with painted on bruises and takes

out another phony assault warrant against Pruett. The wife also gets a 50-B Restraining Order against Mike Pruett and has Pruett evicted from the house. Part of the Restraining Order says that Pruett must not contact his wife.

Then, the wife calls Mike Pruett over 50 times as recorded on Pruett's cell phone and later shown in court to the judge. After all these calls, Pruett breaks down and calls his wife wanting to know why she called. But Bam!! Another charge for violating the 50-B. Restraining Order.

Now, here we are in Court on July 16th.

Attorney Teddy shows the Judge the Sheriff's Department Incident Reports. The Judge rules not guilty on the second assault charge, but based on the 50-B Restraining Order alleged violation, extends the 50-B Restraining Order for a year.

Now Mike Pruett has to go back to Court soon to stand accused of a Probation Violation of the original phony assault charge. No telling what kind of a mess that will turn into.

But, as the wife and mother were leaving the Courtroom on July 16th, Attorney Teddy happened along and the mother quickly delivered to David Teddy a good old fashioned "cussing" for getting Mike Pruett out of the second phony assault charge. The Mama calls Teddy every name in the book. Mostly unprintable. But what stood out the most was the Mama called David Teddy a "Thug" although the Mama and the wife, in their unpunished criminal conspiracy, were the real thugs.

But, upon second thought, the biggest thugs were the Deputies that did not arrest the wife for giving Mike Pruett a black eye as well as the Judge who did not punish the wife when she and her mama were caught red handed by the CCSD Incident Reports in the wife's multiple and sustained perjury.

But, all this is a typical day at the Cleveland County

Kangaroo Courthouse. Women pull this stuff all the time and ALWAYS get away with it. Stay tuned folks, you might hear more about such stuff as this during the upcoming elections of some of the highest elected officials in Cleveland County as well as the cover-ups by the School Board.

And, If you have been stolen from like me. If the crook is caught and convicted and ordered to pay restitution, but doesn't. And is still walking the streets and walking the revolving doors at the Courthouse, maybe then you will realize too just how the Thugs down at the Courthouse, the thugs at CCS, the thugs on the Commissioners, DSS and elsewhere in local government operate. And, with that realization, maybe you will see yourself to the voting booth on Election Day and get rid of as many of those thugs that you can. Starting with Commissioner Eddie Holbrook.
