Now, More information on Restart Schools in Cleveland County!

There are presently six failing schools in Cleveland County and many more on the verge. Possibly ten or twelve altogether. Over one-third of the County's 29 Schools are failing or close to failing. Shelby Middle School was failing recently but a new Principal brought the numbers up before the Restart rule

caught them. Possibly by fudging some numbers???

The Restart rule kicks in when a school fails three years in a row. Bringing in a new principal before the end of the three years of failing scores resets the score keeping for an extra three years before Restart kicks in. CCS has been juggling principals in and out of failing schools for the sole purpose of avoiding Restart. So, there is no accurate count that I have found of just how many low performing schools are close to failing. And for how long.

James Love Elementary School AND Graham Elementary School are presently Restart Schools because there were just too many failing schools at CCS and not quite enough principals available to be juggled long enough to avoid Restart for James Love and Graham.

It should be obvious to all reasonable people that just juggling principals around to avoid Restart is just a cover-up scam that does not address and resolve the problems and social issues related to failing schools in Cleveland County. All CCS administration and the eight phony School Board members have done is cover-up, protect and preserve their corrupt political influences and attempted, many times, to shut-up and shut-down Board Member Danny Blanton. Spending \$130,000 per child for a substandard education during years of attending failing schools.
