Editor's Note: This National Boycott of the 2020 American Legion World Series to be held in Shelby, North Carolina in 2020 was announced to Concerned Parents, the Shelby Star, myself, Shelby Mayor Stan Anthony and others by the Southern Coalition of Equal Protection Under The Law (SCEPUL), a movement for the advancement of justice everywhere by the political "outing" of injustices where and when they are discovered.
