But, hey, Speaker of the House Tim Moore is "bringing home the bacon" to Cleveland County. Can Tim Moore be blamed because the Commissioners let the "bacon" turn rancid and be wasted. So, who cares if the Commissioners waste the Wildlife Commission's funding? Cleveland County Taxpayers will be OK. Right! Right?

Wrong Again folks. The "Devil is in the Details." Under the secret agreement for Cleveland County to get the \$487,500, they have to put up \$161,833.33 using direct taxpayers tax dollars.
