

# **County Broke, But ADDING \$1 Million to Shooting Range!!!**

I think the deal is for 30 years and there are many years yet to go.

Folks, show up for the Commissioner's Meeting Tuesday night at 6:00 PM at the LeGrand Center. Tell the Commissioners that

enough is enough. Stop gouging the taxpayers at every turn. Do NOT raise taxes by re-evaluating property or by raising sales taxes. And leave the Confederate Monument on the old Court Square right where it has been for over 100 years. Cut waste and quit throwing away tax dollars away on the mismanagement at the Fair, the ALWS, the Shooting Range and anything else that can't pay for itself.
