

**“When corrupt politicians start going to jail, we can start trusting the government again.” Willie Green demands District Attorney investigate City of Shelby officials for felony criminal Perjury!!! \$88 Million Lawsuit Settlement by Department of Justice, \$100 Million California Court ruling sets precedent for major city-busting awards!! “When corrupt politicians start going to jail, we can start trusting the government again.” Report and analysis by Robert A. Williams**

Within the past weeks news stories have surfaced that major \$\$\$Millions have been awarded to people for the bad acts of

government agencies and their officials and employees. From Coast to Coast, this is a new phenomenon!!!

**Charleston, South Carolina:** The Department of Justice, just days ago, settled a lawsuit with the families of 14 victims of the Dylann Roof shooting of 14 black people in a Church Service. Nine were killed and five were wounded. The Department of Justice (FBI) had failed to take proper actions in a firearm sale “background check” that allowed Dylann Roof to purchase a firearm used in the Church shootings. **The families were awarded a total of \$88 million for their losses.** Note that Dylann Roof, trying to escape the scene, was finally apprehended in Shelby, North Carolina.

**Cherokee County, North Carolina:** A Cherokee County family was awarded **\$4.6 Million by a jury** because the Cherokee County Department of Social Services used fraudulent “contracts” to separate children from their parents. This award was for one family. There are 30 plus additional families in various other lawsuits against Cherokee County for exactly the same thing. The Cherokee County former DSS Director plea-bargained down to one felony count of obstructing Justice and testimony against others to minimize any prison time the judge might impose on her. The Cherokee DSS Attorney is anticipated to get a long prison sentence for his part. Note that Cleveland County DSS has committed this same crime for years. Perhaps DA Mike Miller will ultimately have to investigate those felony crimes right here in Cleveland County. It is noted that the North Carolina Local Government Commission is working with Cherokee County to attempt to figure a way for Cherokee County to pay off these lawsuit awards without going bankrupt. A daunting task, if at all possible since the Cherokee County Insurance providers have refused to pay off because Cherokee County officials committed crimes in this matter.

**Sacramento, California:** A California Zoning Request Lawsuit, Petrovich Development v. the City of Sacramento, has worked its way all the way up through the California Supreme Court

and all rulings have been in Petrovitch's favor. City of Sacramento officials illegally conspired to "kill" a zoning change request for the construction of gas station in a shopping center. Legal Bills for Petrovich have already exceeded \$100 Million. When punitive damages are finally added, the City of Sacramento is expected to be on the hook for over \$400 Million! It's hard to say that a **\$400 Million** judgement against Sacramento will bankrupt Sacramento, but, I expect, that Sacramento taxpayers will feel lots of pain.

**Wilmington, North Carolina:** The New Hanover County Board of Education (NHCBOE) has just filed a 823 page lawsuit, just four days ago, against a number of people and liability "Insurance Companies" for not paying up when NHCBOE got caught up in sex crimes against students and the following cover-up that lasted for years. By my count, the total awards the NHCBOE are trying to collect from the insurance companies total over **\$80 Million**. And possibly many more million\$. **I am sure the taxpayers in New Hanover County, North Carolina wish they had paid better attention to the corruption going on in their school system and cover-up by their School Board and School Superintendent.**

**Shelby, North Carolina:** Now, Mr. Willie Green has sent a message to the Cleveland (and Lincoln) County District Attorney Mike Miller officially requesting a **Criminal Investigation of Perjury** that starts off **"When corrupt politicians start going to jail, we can start trusting the government again."**

In Mr. Green's previous legal actions against the City of Shelby and certain City of Shelby officials that started as simple Small Claims Court actions, the City of Shelby has continued to use their typical delaying and retaliation tactics that has resulted in the legal actions escalating to higher and higher levels of the Court System as well as a yearlong Federal Investigation of Shelby by the US Housing and Urban Development Agency (HUD). At every level, the City of

Shelby has foolishly stated one thing or another as quick answers to the immediate matters at hand. Completely missing the fact that their stories were changing (or contradicted previous stories) as they went along. The City of Shelby Officials were weaving a web of deception and deceit, one thread at a time. Apparently not realizing that their lies were burying them alive as they went on and on with their same old MO.

But Mr. Green was keeping all his documents in a well-organized manner and was catching every lie, deception, contradiction and perjured statement at every step along the way.

Now, Mr. Green has assembled and presented his information to the District Attorney, clearly showing that one or more Shelby City Officials were undoubtedly committing perjury (and perhaps other felony crimes) in their statements to the Courts, Court Documents, Testimony to Federal Investigators and more. Like to the Shelby Star and to the public.

But I have said enough, I have attached Mr. Green's message to District Attorney Mike Miller (and copied to the State Bureau of Investigation, the NC Attorney General, the news media, HUD and others) below for all to see. And now, YOU can see it too. Join me and the taxpayers of Cleveland County in demanding that DA Mike Miller do his job. **Investigate, prosecute and incarcerate as appropriate.** WE don't want this situation of governmental agencies and officials failing to do their jobs to go any further-such that Shelby's Insurance won't cover the jury awards or settlements. We don't want such shenanigans by Shelby to bankrupt the rest of Cleveland County either.
