□ School Board Member Phillip Glover’s Safe Lane Drivers Education School was registered as an LLC (Limited Liability Corporation) on March 29, 2017 with the Secretary of State of North Carolina. Phillip W. Glover is the Registering Agent. No other names have been found on record of any other person or entity associated with the ownership of Safe Lane Driving School.

□ It has been reported that Driver’s Education through Cleveland County Schools costs parents \$65 and Safe Lane charges \$395.

□ 47 of the 58 Community Colleges in North Carolina, including

Cleveland Community College, teach Driver's Education programs.

□ Since Safe Lane was chartered, three Driver's Education teachers at Cleveland County Schools have retired and were not replaced by CCS-until very recently.

□ Dunn and Bradstreet records show Safeway has seven employees and annual sales of over \$150,000. Those records did not show what year they were talking about.

□ Since early 2020, Safe Lane has been approved to teach Driver's Education remotely over ZOOM and the Safe Lane Driving School was deemed an essential business.

□ Since early 2020, when COVID hit, CCS stopped all Driver's Education programs.

□ Safe Lane's Facebook page photo shows two shiny brand-new Driver's Education cars and Glover himself can drive only one car at a time.

Taking these undisputed facts, one would easily conclude that:

□ CCS, under Superintendent Stephen Fisher, took actions (or inactions like not hiring new Driver's Ed teachers) that financially benefited School Board Member Phillip Glover's private Safeway Driving School.

□ As a School Board member, Phillip Glover would have the opportunity and position to have access to hundreds of potential Driver's Education students' names and contact information.

□ Superintendent Stephen Fisher would have known that school Board member Phillip Glover had access to these records and that Supt. Fisher would have likely provided those records to Glover himself.

□ There is a very high probability that there was an illegal financial collusion between Fisher and Glover to throw Driver's Education students toward Safe Lane Driver's School.

□ There is a very high probability that such an illegal collusion would or could have resulted in some cash or other remuneration (payoffs) between Safe Lane Drivers School and Supt. Stephen Fisher.

□At the very least, there is an unavoidable “appearance” of unethical behavior between both Superintendent Stephen Fisher and School Board member Phillip Glover that demands a THOROUGH criminal investigation by law enforcement.

□School Board Chairman Robert “Luke” Queen has not forwarded such a criminal investigation request to law enforcement, or even mentioned it to the School Board attorney as a possible “Conflict of Interest.”

□North Carolina State Law grants School Boards wide authority to conduct investigations themselves. Even to subpoena witnesses. Yet, Luke does nothing!!!

Folks, all this stuff is going on RIGHT NOW. And, there is a School Board Meeting Monday, December 13, 2021 at 5:00PM.

But that will certainly NOT be the MAIN Event at this December 13th school board meeting. THE main event will be the annual selection of the School Board Chairman and Vice-Chairman. Which will certainly be seen as a precursor to the School Board Elections of 2022 and 2024.

However, remember this. The filing for the 2022 Elections begins at noon December 6th, 2021 and ends at noon December 17th 2021. The Rogue Republicans; Dennis Bailey, Kevin Whisnant, Robert “Luke” Queen, Ron Humphries, David Allen, Wes Westmoreland and others are still trying to recruit and “brainwash” enough RINO Republican candidates to beat incumbent School Board member and announced 2022 School Board Candidate Danny Blanton in the 2022 Republican Primary Election.
