Charlotte TV Station WBTV-3 has been investigating the Cleveland County Department of Social Services for two weeks now. It seems that an 8 year-old-boy was removed from his mother's home by CCDSS and placed in a state regulated group home. Supposedly for the boy's safety. Only thing was, the boy quickly became the victim of numerous sexual abuse assaults in the group home and nobody did anything about it until the boy told his mother about the sexual assault during a visit and the mother called the Cleveland County Sheriff's Department. The CCSD took out criminal charges against the juvenile who had committed the sexual assault. WBTV-t has contacted the CCDSS Director Katie Swanson, the State and just about everybody else and all WBTV-3 gets is the run-around. Nobody

knows nothing DSS says.
