I received a second report on March 2, 2022, that the Crest High School female teacher has been FIRED for sending nudie

porno picture(s). The incident was first reported to be as follows: The Crest High School female teacher had sent a nudie picture from her cell phone to the cell phones of all the students in her class. This report was later revised that the teacher had apparently downloaded the nudie Porno picture from her cell phone to her CCS-owned iPad device and transmitted that picture from the CCS-owned iPad to all her student's CCS-owned iPad. And, there was much more.

But first, let's describe the crime that has happened and how Cleveland County Schools and Cleveland County Law Enforcement should have handled these kinds of episodes in the past.

Disseminating pornographic images to minor children, and maybe to adults too, is likely to be a criminal offense. I have not heard whether or not this teacher has been charged with a crime. I have copied the Cleveland County District Attorney as well as the Sheriff's Office about this incident.

But this is not a new situation for Cleveland County Schools.

Back in 2015 a Burns Middle School female teacher took nudie pictures of herself at home and sent them to two former middle school students of hers on their personal cell phones, who were now in high school. The original sending of the nudie pictures as well as the original receiving of the nudie pictures apparently all happened away from school property. However, somehow these nudie pictures were passed along by the first set of students to other students that were still at Burns Middle School, where they were caught watching the video and turned in to law enforcement. Law Enforcement including Sheriff's Department Captain Joel Shores, who is NOW on the Cleveland County School Board. The nudie pictures also found their way onto the internet and were available on the World Wide Web and traveled around the world. I was personally stopped by a person that knew me at the Walmart in Cherryville, NC who had seen the nudie video. My website records showed that my articles about this incident had been

viewed by other countries-basically around the world. Note that NONE of my articles EVER carried this nudie video. Or ANY" nudie videos. I did include the Teachers Law Enforcement mug shot in my articles as all the local Charlotte area TV Stations also included that mugshot.

Anyway, this Burns Middle School female teacher, in 2015, was "forced" to resign from CCS and was charged by Captain Joel Shores for crimes and prosecuted. She eventually had to spend time in jail (weekends I was told) for her crimes of disseminating pornographic material to a MINOR, although none of her activities apparently ever extended past sending the original nudie pics to two former students that were no longer minors. And none of her own actions occurred on School grounds or used school-owned equipment.

Also, I have had a citizen's comment emailed directly to me asking why this female teacher at Crest High School was fired and the "pedophile" from Burns Middle School who told a female student that he "wanted to slap her butt and twist her titties" was only forced to resign. And almost immediately went to work with the Lincoln County School District. A source from the Courthouse told me that the Male teacher from Burns Middle School would NOT be charged with a criminal offense because his act was only committed with words—that he did not actually touch the female student. Which flies in the face of the criminal charge against a male high-level Cleveland County Republican Party official who was on some sort of website where men and women meet and was lured to the Cleveland Mall by School Board Member Joel Shores, when he worked at the Sheriff's Office, to "hook-up" with this young girl that did not exist. The Republican Official foolishly the bait, went to the Mall and was arrested by Shores and other deputies in a sting operation. So, how come this high-level Republican gets arrested and convicted when he never touched this girl that never existed in the first place?

Now, it appears that School Board member Joel Shores and the

rest of the CCS Administration and School Board have gone soft on pornography being disseminated to school students, on school premises, and by School teachers. I have delayed reporting about this until today, March 7, 2022. You will soon understand why!

My very timely report of this newest Porno related incident at Crest High School (within hours of the Crest High School incident actually happening), on top of the Burns Middle School report, was a critical "one-two" punch that exposed both the CCS Superintendent AND the School Board, at almost exactly the same time, was just too big for CCS and the Shelby Star to cover-up. It is was also a slight possibility that the Crest High School female teacher was NOT officially "fired" as my sources originally told me, just forced to resign like the male Burns Middle School teacher, and those reporting these incidents didn't fully understand the differences. As I previously stated, Superintendent Fisher should be forced to resign Tomorrow and Chairman Luke Queen should be forced to resign this coming Monday.
