As you can clearly see, the text message is Paid for by Robert P. Queen and endorses four candidates of the seven candidates that are running for the school board in the 2022 Cleveland County School Board Primary Elections.

Also, Mr. Robert P. Queen is the Chairman of the Cleveland County School Board and is, according to School Board Policy 7720 the OFFICIAL Spokesperson for the Cleveland County School Board and, according to that **Policy 7720 Employee Political Activity** is prohibited as follows:

Policy 7720 states (in part)

**As specified in policy, the Chairperson of the Cleveland County Board of Education or designee and the Superintendent or designee are the official spokespersons for the school system. Employees, when exercising their rights as citizens, should take steps to ensure that their personal political activities or opinions are not erroneously attributed to the Board or the school system.**

So, folks, it has come to this:

- 1.It is Totally against School Board policy for Chairman Robert "Luke" Queen to be undertaking personnel political activities such as sending out this Robo-Email text message all across Cleveland County.
- 2.It is totally against the **North Carolina Republican Party Plan of Organization** (Page 37) for CC Republican Party Executive Committee member Robert "Luke" Queen to make specific endorsements in Republican Party Primary Elections.
- 3.The NC Republican Party Plan of Organization (Page 37) states that any Republican official or Executive Committee member that endorsed candidates during a Republican Primary Election shall immediately forfeit their office or Executive Committee membership.
- 4.Cleveland County Republican Party Chairman David Allen, as well as Robert "Luke" Queen have both violated the rules of their office, in multiple incidents and multiple times.
- 5.David Allen's email does not speak to Robert Queens

violations and forfeiture of Office.

6. David Allen also does not speak to the other Rogue Republicans, such as himself, Kevin Whisnant, Wes Westmoreland and the others noted above as forfeiting their offices in the North Carolina and Cleveland County Republican Party.

So, what do "Regular" Cleveland County Republicans think about all of this?
