That **“I knew Queen had a “roving eye” the first time I met him. But I would not have guessed her (XYZ) being one of his affairs.”** I turned around from my front-row seat and I see all these “eye-candy” mothers of these kids sitting there under the “roving eyes” of Robert Queen. Doing his own investigations and then telling the public. Things that the PUBLIC would expect and demand **ALL School Board Members should do**. But twist it around into something that would sound very bad about Blanton to **low information voters**. Especially if they would get the "lapdogs" at the Shelby Daily Liar to go along. Right at Election time.

So, that is exactly what **Shelby Liar** did. Go along with the Rogue Republicans since the Shelby Liar gets lots of subscription\$\$\$ directly from CCS for the Non-Existent Newspapers in Education Program. The Shelby Daily Liar stated that Superintendent "Fisher did not reply to a request for a comment on Blanton's account."
