

**If GOD doesn't destroy the Cleveland County Library, CCS and the Cleveland County GOP Executive Committee; He owes Sodom and Gomorrah an APOLOGY!!! God will have to do it because the Commissioners refuse to!! Educational Disaster at Cleveland County Schools!! Report, commentary and WWJD analysis by Robert A.**

Saturday June 18, 2022 was just that kind of day that shows what Cleveland County is made of. And NOOOObody should be proud!!

The brouhaha started at 10:00 AM with the CLOSED-DOOR Meeting of the Cleveland County GOP Executive Committee that was held at the Cleveland County Library in Shelby at 10 AM. That meeting agenda was also secret, if there was a "published" agenda at all. One has to wonder why the CCGOP Executive Committee has to meet in secret and NOT allow the Rank and File Republicans to even sit there silently and listen to what goes on. Robert A will say right now that he is a Registered Republican under State Law but "stands apart" from the Cleveland County GOP. Robert A is a "Trump Conservative"

Republican, like most of us here in Cleveland County who believes that America, including Cleveland County, can be made GREAT again. Trump Republicans don't need to meet in secret, to hide behind closed doors and put out lies and deception as a means to make ourselves sound respectable to those that don't know us. We don't need to lower ourselves into deception, into believing that a person has to go "low" to make ourselves seem "high and mighty" to strangers.

For that reason, Robert A decided NOT to "crash" the CCGOP Executive Board meeting and make them "throw" him out, as he knew they would. Robert A would not give them a reason to change, in any way, what they were about to do. Or NOT to do. Robert A would find out, soon enough, what happened at that secret meeting, as he always does. And then make his report.

School Board Candidate Ronnie Grigg had a different situation. But that was NOT the only scandal. A bigger and more of a MAJOR SCANDAL, a WIDENING SCANDAL, was discovered at the Cleveland County Library in Shelby on that fateful day-Saturday, June 18, 2022.

Commissioner Doug Brides, a CCGOP Executive Board member, who also serves on the Cleveland County Library Board, was on the way to that 10 AM meeting when he passed by a kiosk (a four sided stand of book shelves) that must have contained at least 50 hard back books that all extolled the merits of Homosexuality. A veritable guide to all kinds of perversion and deviant sexual behavior that stood no more than three baby steps from the main office area of the Library. It was "Gay Pride" Month at the Library and the Library went all-in with the program. At TAXPAYERS expense.

Commissioner Bridges picked up one of those books filled with filth and headed for the Meeting Room where all the other CCGOP Executive Board members were to meet. At the door, an alarm went off as Commissioner Bridges had not checked out that book. So, Bridges returned the offending book to the kiosk and went into the meeting room without the book, but told everybody about his discovery.

Good for Commissioner Bridges for sounding the alarm. BAD for Commissioner Bridges because he was on the Library Board and the Library Board had allowed large sums of Taxpayer money to be spent on the purchase of such literary "filth," apparently without a review of the Library Board/ to begin with. And place it center-stage in the Library where all the kids in

kids' programs at the Library would see them.

It was the Monday afterward that Robert A was made aware that there were things at the Shelby Library that he needed to see. That there were Gay Pride books in well-travelled places at the Library. (Not like in the back rooms of "Dirty Book Stores.") Along with the bits of information about the sorry state of affairs within the CCGOP Executive Committee.

So, that following Tuesday Morning, bright and early, Robert A walks through the front doors of the Cleveland County Library in Shelby NC. The County with over 200 Christian Churches.

Robert A plotted out his search pattern, and spent a good two+ hours going through the Kid's books. In shocked disbelief. What Robert A found was worse than he had ever imagined possible right here in Cleveland County. With Christian Churches on almost every corner. Something BAD had happened

right under the noses of the majority of Cleveland County citizens, Especially the majority of parents who were NOT paying attention to the filth, reverse racism and sexual depravity their children were being subjected to every day. "Every day" meaning that this Cleveland County Library had to be a reflection of what was contained in the 29 Cleveland County Schools Libraries (Now called "Media Centers") scattered out around Cleveland County.

This would NOT be Robert A's last shocking discovery of the day.

Robert A takes two steps inside the Cleveland County Library (That's the name on the plaque on the outside wall to the Left of the entrance doors.) Kids Section and steps up to the kiosk directly in front of him. All filled with books, NEW books, with bright and shiny kid's smiling faces. Mostly bright and shiny black and brown faced kid's smiling faces.

The first book Robert A picks up in the Kids Section is titled "Our Skin: A First Conversation about Race." Robert A thumbs through this book and makes notes:

- CRT (Critical Race Theory) “incarnated” for children.
- Teachers-Race mixing and racism
- Teachers-White people get more power and are treated better than everybody else
- Racism happens in lots of big and small ways. It is all around us even if we don’t always notice it
- Advocates speaking out, protests are progress and Black Lives Matter

In another book title Brandon Speaks Out, a black kid that stutters is very much positively influenced by President Joe Biden. Robert A didn’t get the message, if there was one on this passage. But when he picked up a book titled America ABC, he noticed that “A” was for Abraham Lincoln, “M” was for Martin Luther King, Jr. “X” was for Malcolm X “W” was for the White House. Robert A would have thought that at least W would stand for George Washington. Our FIRST President. So, Robert A thumbed back through the book carefully and found that, although Abraham Lincoln was mentioned, NO other white person was mentioned. No George Washington, No Thomas Jefferson. There was a book titled Together We March: 15 Protest Movements that marched into History.

Then there was tis book. “Hear My Voice: The Testimony of children detained at the Southern Border.” Again, a kid’s book that requires a grown-up (society) solutions.

So, why were these kinds of books filling up the Cleveland County Library’s Kid’s Section???

- 2.The first few pages cast the image of a positive learning experience for the readers-kids.
- 3.About midway, the lessons became more like indoctrination. There were social issues like racism, Global Warming, Protesting and social upheavals were good and the “right” things to do, Black Lives Matter, Critical Race Theory, White Supremacy, Social and Emotional learning, Anything divisive. Nothing about building a child’s character, critical thinking skills, finding the truth of the matter, doing good deeds, honoring your father AND mother, Respecting your elders, obedience at home and at school, and other such good and proper things.
- 4.Toward the end, the kids were led to believe that Socialism would save the day for a decrepit, racist and white supremacist America. And a good and wonderful socialist government and socialist leadership would ultimately cure what ails America.

Folks, as Robert A made my way around the Library’s Kids Section he tried to make sure he looked at a good cross-section of the books on the Kiosks and in the shelves too. A representative sample. There were literally hundreds and maybe thousands of children’s books. So, I made an effort to seek out kid’s books that might be more like what a reasonable person would consider appropriate for a kid’s book. Books that taught patriotism. Books that taught doing good deeds. Like helping an elderly person carry their groceries or cross the street. Something about seeking out a Policeman for help finding your way if you were a kid and had lost your way. Books about Good behavior, bravery and good citizenship. None of that was to be found by Robert A, who made a good faith effort to look for those things too.

So, Robert A upped the ante. He began looking all around for children’s Bible Stories. What he found was a big fat ZERO.

Nothing. NADA!!!
