

Rogue Republican Dirty Tricks starting up in School Board Elections!! School Board Member Dr. Danny Blanton being attacked again!! Also, expect more Dirty Tricks targeting Candidate Ronnie Grigg!!! Usual crowd suspected!!! Report and commentary by Robert A

An email from NewsBreak-Local Newsletter came in at 7:39AM July 14, 2022 titled "Cleveland County School Board member defends Facebook post he shared displaying a paddle." Robert A immediately "smelled a rat" and clicked on all the right links to get to the story. The report was directly from WBTV Channel 3. Perhaps many of you saw this on TV news today. The Channel 3 News stated School Board Member and candidate for reelection in the 2022 Elections, Dr. Danny Blanton, was "under fire" because he (Dr. Blanton) had shared a picture on Facebook showing a paddle (for spanking kids) with painted on

words stating "Make Kids Great Again." Which clearly meant to the citizens of Cleveland County that discipline should be returned to Cleveland County Schools.

Robert A also notes that the picture was shared by Mr. Blanton about 3 weeks ago on his private and personal Facebook Page and clearly was Mr. Blanton's own personal belief and not in any way associated with his school board membership. That picture has been copied from the Facebook page as noted and is shown at the bottom of this article.

Also, about 99% of the posts on Facebook related to this picture were favorable to Dr. Danny Blanton. Those almost 300 Facebook posts as well as Robert A believe that Dr. Danny Blanton is doing an excellent job as a CCS School Board Member and also believe that discipline needs to be returned to CCS Classrooms. In fact, a mother spoke at the June 13, School Board meeting informing the full Board as well as the public that her child had been stabbed at school and CCS, including the School Board, had done nothing to protect her child. That her child had been suspended from school and the attacker had NOT been suspended. The mother also stated that she had called ALL the School Board Members and only Dr. Danny Blanton would talk to her.

Also, the Channel 3 reporter had also checked North Carolina LAW and found that there is NO prohibition of corporal punishment at North Carolina Schools per State law and that Cleveland County Schools had themselves banned corporal punishment with their own Policies. A policy that demands change as soon as possible for obvious reasons. For violence, bullying and such is rampant at CCS as well as a jail full of inmates that did not learn any discipline while at home or at school in Cleveland County Schools. Also note that Pinnacle Classical Academy also does NOT have such a violence problem as CCS. Robert A does not know whether Pinnacle Classical Academy uses corporal punishment or not. 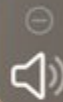
