□The large display case that had previously held only LBGTQ-XYZ books and materials had been removed and replaced with a smaller display case. There were now four such display cases around the book checkout area and other larger display shelves with high visibility.

□The LBGTQ-XYZ books that had initially been concentrated in that one big case were now placed in all those other display cases, mixed in with a few other books.

□The LBGTQ-XYZ books seemed to be concentrated below the direct line of site for an adult, but were exactly at the proper line of sight for children.

□A cursory inspection of other displays that were not so close to the central book checkout center also included an obviously high percentage of LBGTQ-XYX books.

□All books on Display were stacked in such a manner that the Book Covers were aligned in such a manner that the full front of the Book was in view relative to a normal bookshelf where a much smaller area of the book end is exposed.

□There were plenty of other shelves in the library marked with such terms as "Adult-Non-Fiction" where these LBGTQ-XYZ books, totally age-inappropriate and subject inappropriate for viewing by children, could have been re-located to. But they weren't.

The obvious conclusion here is the Shelby Library AND Cleveland County Schools have given the "Middle Finger" to

parents, Conservatives of all stripes and the hapless and mentally helpless Cleveland County Rogue Republican Leadership. The Commissioners, the School Board, the County Manager and the Assistant County Manager too.
