

**Business is Booming for Mr. Willie Green at his Athens Sports Arena!! City of Athens, GA Partners with Mr. Green to fight gang violence. In the meantime, as Mr. Green was completing his phased renovation of his facilities, Mr. Green was approached by various factions of the Athens/Clarke County Community, Sports teams, Clubs, Civic Organizations, Community Organizations. Parents whose children were getting married and looking for places to hold the various events, and about everything else under the sun. All looking for a safe place to hold their events.
