

Part 3: Nov 21 School Board Meeting Separated the “Wheat” from the Chaff!! Only Dr. Danny Blanton wanted to do what was right!!! CCS Chairman Luke Queen falsely says CCS sets Good Example for NC and USA! –\$100 Reward Offered for PROOF!! Report, Commentary and \$100 REWARD offered by Robert A
