

# **Feds say Catawba Kings Mountain Casino Broke Federal Laws!!! Cleveland County is Hiding Casino related Documents!!! Did Cleveland County Break Federal Laws too??? Report and commentary by Robert A**

Note that in certain ways Cleveland County already does such things to their own citizens in the form of Property Taxes, Sales taxes, Permyty fees, etc. Especially with Commissioner Chairman Kevin “Mad Dog” Gordon’s continuing push to increase revenues by increases in all of the above.
