

**School Board Chairman Robert Queen wins Re-election on 5-4 vote Was running unopposed for Chairman!!!??? Luke's Tie-Breaking Vote made while under the influence of Drugs!!!??? Vice-Chairman Joel Shores wins re-election-also on split vote!!! Eyewitness report by Robert A**

The December 12, 2022 School Board meeting was full of disagreement, turmoil, dissention. chaos and mayhem. Literally from start to finish. And on almost all occasions in-between. All this bad stuff actually started last March when Robert "Luke" Queen, Ron Humphries, Joel Shores, Dennis Bailey, Kevin Whisnant, David Allen, Pam Keller, Wes Westmoreland, Guy Smith, Hayden Soloway and other Rogue Republicans planned a dirty scheme to recruit enough Republican candidates to defeat Danny Blanton in the 2022 Republican School Board Primary Elections.

Much has already been reported regarding these initial Dennis Bailey, Robert Queen and Kevin Whisnant dirty schemes that totally failed. Then the General Election Dirty Tricks that

included the Rogue Republicans urging Republican voters to vote for two Democrats to defeat Danny Blanton and Ronnie Grigg in the November 8, 2022 General Elections. Which also failed by a very, verv, very large margin.

In the end, Republicans Danny Blanton, Ronnie Grigg, Aaron Bridges and Walter Scott Spurling won election to the School Board in the 2022 Elections. Spurling goes through the surgery and Queen arranges for CCS to provide a communications link between the School Board Meeting place and Walter Scott Spurling. Either still at the hospital in the recovery room or at home in bed. It is normal for such knee surgery to include a 7 to 10-day prescription for a narcotic painkilling drug. So, now we are at the School Board meeting at 5:00 PM and the swearing in of Danny Blanton, Ronnie Grigg and Aaron Bridges. Everybody has now been sworn in and it is time to elect School Board officers. Chairman and Vice-Chairman. Supt. Stephen Fisher takes over running the meeting from Luke Queen and the nominations for Chairman get started.

Ron Humphries is nominated, but instantly declines to serve as chairman. Then Robert Queen is nominated for Chairman. Nobody else is nominated and Robert Luke Queen is now running for Chairman unopposed.

The vote is taken, Robert Queen votes for himself. Ron Humphries, Joel Shores and Greg Taylor vote for Robert Queen. Rodney Fitch, Ronnie Grigg, Aaron Bridges and Danny Blanton vote against Robert Queen. It is a 4-4 tie vote. Fisher asks Walter Scott Spurling, through the communications link for his vote. In a drugged-up sounding voice, Walter Scott Spurling votes FOR Robert Queen.

Fisher then declares the unopposed candidate for Chairman, Robert Queen as the newly elected Chairman by a 5-4 vote.

Then, Robert Queen takes over as chairman and declares the nominations for Vice Chairman open for nomination. Danny Blanton and Joel Shores are nominated. Aaron Bridges, Ronnie Grigg and Danny Blanton vote for Danny Blanton. Shores questions Aaron Bridges' vote and Bridges changes his vote from Danny Blanton to Joel Shores.

Joel Shores, Ron Humphries, Greg Taylor, Robert Queen, Rodney Fitch and now Aaron Bridges vote for Joel Shores. Ronnie Grigg and Danny Blanton vote for Danny Blanton.

Then Robert Queen asks Walter Scott Spurling for his vote and there was no immediate answer. Queen again asks Spurling for his vote and again a drugged -up sounding voice says Joel Shores. Joel Shores is announced the re-elected vice-chairman.

Then Robert Queen goes back to the other items on the agenda. Several other times during the meeting when votes were required, Walter Scott Spurling has to be asked several times for his vote, and every time Spurling answers, his voice sounds like he had been asleep or drugged up and had to be awakened.
