

Cleveland County Employees Heading for the Hills!!! Burke County appears to be the favored destination!! But ANYWHERE besides Cleveland County and Kevin Gordon!!! Facts and Opinions by Robert A

Perhaps the County's greed is a big part of what has killed the County's Goose that was to lay golden eggs. (Also note that this particular County Attorney that is now gone also made a similar entry to his signature to another document. The Cleveland County Board of Commissioners Resolution for Good Governance (CCBOCRGG). A "Resolution" that has noting to do with good governance. Only to try to keep other Commissioners in line with Chairman Kevin Gordon. Note that ALL the Commissioners signed.
