Fitch has had to move out of his home because of his affair. Detention Officers have claimed that they have never met Fitch since they started working in the jail."

Other gossip reports received by <u>Robert A</u> in the past have indicated Rodney Fitch had a girlfriend in the Detention Center. A woman who lived in another county and received a speeding ticket and a DWI from the Shelby Police Department.
