The Tyranny of the Majority on the CCS School Board!! How to Defeat it!! Plandeveloped by Robert A

- five seats. A MAJORITY of the nine seat CCS School Board. Therefore, five good school board candidates in the 2024 School Board Republican Primary Election can defeat the worst five of the six school board majority tyrants. All at the same time.
- 4. Newly elected School Board member Aaron Bridges has shown a resistance to the tyranny of the Majority with his recent voting positions.

Now for a strategic plan to reform the School Board in the shortest period of time.

- 1. Move Danny Blanton, Ronnie Grigg and Aaron Bridges from the minority, four seat cycle to the majority five seat cycle-all with four-year terms after the 2024 Primary School Board Elections.
