Biting Dogs: In recent articles, Robert A reported that three women came to speak at a recent County Commissioner's Meeting to inform the Commissioners of vicious, mean, aggressive, BIG and biting dogs running loose on and around the 800 Block of Kings Road. Since Rabies is a deadly and 100% fatal disease and nothing had been done by the County Commissioners that was reported, Robert A signed up to speak at that next commissioners and asked about this biting dog situation. Robert A also asked the commissioners if them just saying in the minutes of the original meeting that the "situation was handled;" "Was that just another way of saying that nothing was done." The Commissioners refused to answer to anything.
