Also, please include in your Prayer a request to our Maker to lead, guide and direct School Board Members Ronnie Grigg, Danny Blanton and Aaron Bridges in their continued investigation of the Vandalism at Burns High School that they have already begun.

Also include in your Prayer a request for Devine assistance for Samantha Davis in her quest at Parents Against Bullying, NC, LLC to eradicate Bullying at Cleveland County Schools.

Please note the following CCS Special Called Meeting Agenda (below) for the order of the Invocation in the meeting. And, remember to Rise and recite your silent Prayer for 45-60 seconds. Prepare your children to do the same. Let the School Board see for themselves the REAL reason that the School Board exists in the FIRST PLACE.
