This past Wednesday Speaker of the House Tim Moore sat down for a personal interview with the Raleigh **News and Observer** regarding his “Alienation of Affection” Lawsuit. In that interview Tim admitted sexual relations with Jamie Liles Lassiter over the course of three years with the caveat that “She said that she was separated from her husband.” Tim Claimed that the relationship “was on and off again” during this time. That the lawsuit was “Political.” That everything
