

# **The Tim Moore Lawsuit brings in MORE and MORE Media Attention!! From the New York Post to Political Smackdown to Robert A!! Fair and Balanced Report and Commentary by Robert A**

According to this official public record Mrs. Jamie Lassiter lived at the same address with Mr. Scott Lassiter as man and wife during the whole time that Tim Moore and Mrs. Jamie Lassiter were doing their "carrying on."
