Also note that there were two other good examples of the incompetence and arrogance of the Robert Queen led school board, on top of the corruption regarding the Robert Queen led School Board. One was the speaker, Nannette Leonhart, who spoke right after Queen's ten-minute cool-down recess defining; transparency. lies, go along to get along, truth, independent thinking, eye witness reporting, untruth, falsehoods, deception, deceit, cover-up, bullying, harassment, etc. All describing the Robert Queen led School Board as well as the July 25, 2023 email generated by School Board Chairman Robert Queens past midnight fit of rage caused by Danny Blanton questioning Robert Queen's continuously changing and totally unfollowable financial accounting regarding the Shelby High School's Fieldhouse renovations. Title IX violations that Queen never mentions.

Even more to the point of Queen's email regarding Queen accusing Danny Blanton not keeping his facts straight was the next speaker, Robert A, who questioned the Million Dollar HVAC project at the Shelby High School Vocational Building being described by only ten words in the Project Report submitted to the entire school board and the Invoice for large amounts regarding another electrical invoice related to the Malcom Brown Auditorium at Shelby High School only stating that "The Controls are obsolete," which is only four words. Take out "The" and "Are" from the description and you only have two words. "Controls" and "obsolete." Remember these points for further evaluation of Queen's false allegations against Danny Blanton in Queen's defamatory email. Also, remember this is how Robert Queen, Ron Humphries, Joel Shores, Rodney Fitch, Greg Taylor and Walter Spurling spend taxpayer's dollars. In Large amounts with little description and NO accountability. And Robert A told them so!!! Even though the minutes for that June 12th, 2023 School Board meeting do not record one word of what ANY of those Public Participation speakers had to say. Another way Robert Queen and his Waterboys will use for their 2024 re-election campaign lies and deceptions.

The last speaker of the public participation segment was concerned about the closing of the Graham and Marion Elementary Schools and the subsequent and serious overcrowding of the Jefferson Elementary School. The speaker noted that Robert Queen had promised a public meeting with concerned parents and citizens regarding these school closings but that this promised public meeting had never been scheduled nor had it had it ever happened despite that promise by Robert Queen, Chairman of the CCS School Board. Robert Queen did not question the comment nor did he offer any explanation of why he had reneged on his promise to hold this public meeting. Perhaps the high and mighty Robert Queen ought to try to keep his facts and lies straight. And separate out his big lies from the facts of the matter.

2.First, you said that the board did not properly amend the agenda at the June 12th board meeting to move the closed session to an earlier point in the meeting. This claim is completely false.

Editor's Note: Although this was the first statement in Queen's email Paragraph 2, it actually happened after the 10-Minute Recess and after the end of the total Citizens Participation section. Another indication of Queen's remaining rage and anger at being powerless in illegally removing Lady Liberty from the school board meeting and his showing out in his many fits of anger and vengeance toward anybody that does not agree or accept his lies, high crimes and misdemeanors.

The facts of the matter at the June 12, 2023 School Board meeting regarding this Closed Session rescheduling issue are these:

□Adopting the agenda for the June 12, 2023 was the first official business of the June 12, 2023. Adopting the agenda showing a CLOSED SESSION at the very end of that meeting was unanimously approved by all nine school board members without question, discussion or comment.

□Public Participation was the only agenda item that was between Adopting the originally submitted agenda that was approved 9-0 and Ron Humphries whispered comment to Robert Queen and then Humphries motion to move the End of the Meeting Closed Session up to the point of being held right after Public Participation. Danny Blanton asked "why" was this Closed Session item being moved and NOBODY offered any reasons. Queen called for a vote and Danny Blanton, Ronnie Grigg and Aaron Bridges voted NO. Ron Humphries, Robert Queen, Joel Shores, Greg Taylor, Rodney Fitch and Walter Scott Spurling voted to move the Closed Session without offering one word of rhyme or reason.

□However, the reason was obvious to Robert A and all the others that were present at this June 12, 2023 school board meeting. Chairman Robert Queen had once again lost his temper

badly when Lady Liberty made factually correct statements about him (Robert Queen) and other school board members during Public Participation and a 10 Minute Recess was called. When Robert A and others made factually correct statements during the end of Public Participation session, Robert Queen was on the verge of an explosion of anger, fits of rage and serious aberrant behavior of some sort. Ron Humphries, Joel Shores, Robert Queen, Rodney Fitch, Greg Taylor and Walter Scott Spurling all knew Robert Queen was about to explode. That was their way of getting Queen out of public sight until he could cool down. The Closed Session lasted for at least an hour and a half.

□When the Closed Session was over and Robert Queen announces that Superintendent Stephen Fisher and all his supporting staff had had their contracts renewed until June 31, 2027 with big raises to boot. When Danny Blanton asked for the vote count on that recommendation, Queen illegally refused to provide that vote count. But little birdies have advised Robert A that this silly and illegal vote in Closed session was NOT unanimous!!

3.A motion was made and seconded to amend the agenda to move closed session to the next agenda item.

This item was also covered sufficiently in the above section account.

Paragraph 4 of Queens July 25, 2023 Defamatory and incorrect email stated: Finally, during the Operations discussion, you (Danny Blanton) claimed you didn't know anything about the additional \$200k allotment toward the Shelby High field house from the SCIF Grant. If you will go back to the June 12th video at the 2:45:00 mark, you will hear the discussion of the Shelby field house monies and the additional funds that were allotted. I gave you the same explanation then as I did tonight. It's time to get your facts straight.

1, Robert A went back to the official and approved minutes of the June 12th, 2023 School Board Meeting and found that the additional \$200k "reallocation" of funds was requested by Superintendent Stephen Fisher in the June 2, 2023 Operations Committee meeting that Danny Blanton was barred from attending. The Operations Committee Report failed to identify what this \$200K funding was to be used for. The Operations Committee Report stated the \$200K reallocation was unanimously approved by the Operations Committee (minus the absent Danny Blanton). However, the APPROVED June 12th, 2023 School Board Meeting Minutes, Action Item 8.05, did NOT SHOW that there was a vote by the full School Board to approve that \$200K reallocation of funding that Supt Fisher had requested.

2. Approved minutes of School Board Meetings are the official and legal documentation of what transpired at that particular School Board Meeting. Therefore, the lack of a vote to approve a \$200,000 reallocation of funds as shown in the Official Minutes of that June 12, 2024 School Board meeting legally means that any \$200,000 reallocation of funds was NOT approved by the full School Board.

Robert Queen would be well served if he would only listen to what Danny Blanton had to say instead of always cutting him off and telling him that he needs to get his facts straight. As it is, if that \$200,000 has been reallocated by Robert Queen without official full board approval, Robert Queen and his Waterboys have EMBERZZLED that \$200,000 for their own purposes. Which is a felony crime!!!

Also, this is just another good example of Robert Queen and his bogus Committees doing sloppy work with poor to no documentation of their actions and the discussions that may or may not have taken place.

Editor's Note: The conclusion of this whole episode is that Robert Queen, Joel Shores, Ron Humphries, Rodney Fitch and Greg Taylor all need to be replaced by the voters in Cleveland County in the 2024 Elections.
