

CC Commissioners giveaway \$3,540,000 on Project Sunrise!!! Very Likely a Communist China Owned Company!

The company would manufacture composite external insulation products for the power transmission and distribution. This secret company would hire 134 employees over 5 years at an average salary of \$22 per hour. The County and the City of Shelby would split the incentive cost (\$3,590,400) previously noted for the purpose of clearing and grading this property.

At this point, Robert A did some quick and rough "ciphering." This secret company was to purchase around 100 acres at 22,000 per acre. This would amount to around \$2,200,000. Then the County and Shelby would give the company \$3,590,400 to clear and grade the property. Basically, after the secret company paid Cleveland County \$2,200,000 and Cleveland County paid the secret company \$3,590,400 for clearing and grading, the Cleveland County taxpayers would be "in the hole" for around \$1,390,400!! Was this a stupid and backwards deal or what?? We are selling land to this secret company and paying them \$1,390,400 to take it. No wonder Kristin Reese had resigned. These Commissioners; Kevin Gordon, Johnny Hutchins, Ronnie Whetstine, Deb Hardin and Doug Bridges would have to be MORONS amongst Morons to agree to such a stupid deal as this, was Robert A's first thoughts.
