

# 2024 Political Campaigns Starting Early!! Robert A Williams to Run for Cleveland County Commissioner!! Starts “Political Action Committee”: TAKE BACK CLEVELAND COUNTY!! News Flash by Robert A

Very egregious and UGLY politically motivated acts of Constitutional Rights violations, Discrimination, unethical acts of deception, and abuse of power perpetrated by the Cleveland County Commissioners at the September 5<sup>th</sup>, 2023 Commissioners Meeting; done under the guidance and direction of Commissioner Chairman Kevin Gordon, has caused Robert A to finally decide to commit to the task of running for elected office.
