## Cleveland County Rumor Reports:

Editor's Note: Today Robert A received two phone calls "Rumors" and one defamatory letter regarding three school board members. Folks, the 2024 Elections are going to be the dirtiest political event of all time in Cleveland County HISTORY! Nope, just in the 21<sup>st</sup> Century.

### Rumors:
