## Part 2-Local 2024 Republican Primary Elections!! Incumbent CCS School Board Member Candidates are all Hiding from their Sorry Records in Office!!!

Editor's Note: Incumbent CCS School Board Members Robert Queen, Joel Shores, Ron Humphries, Rodney Fitch and Greg Taylor are trying to Deceive everybody. Some background: The remodeling of the old Shelby High School Building at 400 West Marion Street around 15 years ago was controversial for many reasons. The Costs of this remodeling

was about \$5 million overbudget. Those over-budget costs were partially covered up from the public by using CCS Maintenance people to do as much work as possible and charge their time to other CCS accounts. And, perhaps other unacceptable accounting tricks were used. But, to the point, the Old Shelby High School Auditorium remodel job included a new air conditioning installation. Beam Construction was the remodeling contractor and Holland & Hamrick was the remodeling Architect firm. And, the newly remodeled Auditorium would most often be used to hold CCS School Board Meetings.

As fate would have it, <u>Robert A</u> has had many years of Engineering Design, Construction, Operating and Maintenance experience, which once included the air conditioning system design and installation for an auditorium remodel job at a nearby University. And, one of the requirements for that installation was an air conditioning system that operated silently so as to NOT interfere with the audience's ability to hear the performance of the actors on stage. <u>Robert A</u> took this into consideration of the auditorium HVAC system. And, the customer's drama classes were 100% satisfied with the results.

However, once <u>Robert A</u>. began attending CCS School Board meetings, it was clearly obvious to <u>Robert A</u> that the Old Shelby High School Auditorium remodeling job had major design flaws and deficiencies that could cause excessively loud background noise in the Burns and Crest High Schools Auditoriums. First, the air conditioning chiller at CCS was not purchased with noise abatement features. Second, that chiller was installed closely adjacent to the West Wall of the Auditorium. All of which caused excessive chiller background noise in the Auditorium. Third, the A/C fans also made excessive noise when operating. In other words, this Auditorium remodeling job would have been deemed unacceptable to any event held in that auditorium. Including School Board meetings. To compensate, sound systems were installed in the

CCS Auditorium for School Board meetings.

Now, the CCS School Board has spent \$30 Million\$ to build new auditoriums at Burns and Crest High Schools. The very same Architect Firm and Construction Company that designed and installed the Air Conditioning system at the Old Shelby High School Auditorium remodel has designed and constructed the new \$30 Million\$ auditoriums at Burns and Crest High Schools. And, at no time have the CCS School Board ever mentioned the noise problem at the Old Shelby High School Auditorium remodel, nor indicated that they are even aware of a need for silence in either the Old Shelby High School Auditorium or the Burns and Crest High School Auditoriums. Only time will tell whether or not the Burns and Crest High School auditoriums are first \$30 Million\$ "last-class" installations. 0 r installations that Burns and Crest High Schools usually get from this CCS School Board Majority that consists of Chairman Robert Queen, Joel Shores, Ron Humphries, Rodney Fitch, Greg Taylor and Walter Scott Spurling (who is not up for reelection in 2024.

So, whether or not the Burns and Crest \$30 Million dollar\$ auditoriums are worth the time, effort and costs remain to be seen. Hopefully it is acceptable for the intended purpose. But it will likely be "luck" more than anything else. Or maybe a population of people in the Burns and Crest School districts who are used to being screwed over.

As far as <u>Robert A</u> is concerned, the CCS School Board had all the indications they needed to ensure the Burns and Crest Auditoriums are successful. Yet, none of this was ever mentioned at the 100 plus school board meetings that <u>Robert A</u> has attended.
