CCS School Board Member Rodney Fitch Speaks Out!!! "WHY DO YOU TELL LIES ONLY ABOUT ME??"

Editor's Note: Rodney Fitch (along with Robert Queen, Ron Humphries, Joel Shores and Greg Taylor) was one of group of five School Board Candidates who ALL lied to the public to get elected to the School Board in 2020. Yet, as a group of five (Rogue) Republicans, which represents a MAJORITY on the 9member CCS School Board! They ALL vote in lockstep on every vote to enforce a "secrecy" upon the School Board like never before seen in Cleveland County history. Hiding a massive amount of cover-up that includes overseeing the CCS annual budget increase from around \$150 MILLION to \$250 MILLION+. All the while CCS student attendance was shrinking from a high of 15 to 17 thousand students down to around 14 thousand students in 2024. With most attending almost 60-year-old schools (average age) and with educational effectiveness being severely substandard according to NC Department of Public Instruction records. Note that School Board member Danny Blanton read into the record at a recent school board meeting that new grading of academic achievement gives anything over a score of 24 out of 100 is a passing grade.

Also, note that Rodney Fitch, as an elected CCS School Board Member has found himself in a number of personal controversies:

 Robert Ahas recently witnessed Rodney Fitch presenting to the CCS School Board at an official school board meeting some kind of agreement between the CCS School Board and the local "Pickleball" association for approval or recognition. At that time Robert A thought this was a bit of a conflict of interest, but did not rise to the level of being anything important enough to mention. Especially with all the other "stuff" going on at CCS and Rodney Fitch.

- There has been lots of "gossip" between lots of people around Cleveland County that Rodney Fitch has (or had) a "Pickleball Girlfriend" that caused division in Rodney Fitch's marriage that resulted in Rodney Fitch moving out of his marital residence and relocating into a camper that is alleged to be parked somewhere near Polkville.
- During the 2024 Early Voting in the School Board Primary Elections at the Library in Shelby, "somebody" allegedly called Rodney Fitch at work and told Rodney Fitch that Danny Blanton and Ronnie Grigg had stolen some of Fitch's Campaign Signs. Allegedly Rodney Fitch left work, "roared" over to the Shelby Library, parked in a Handicapped Parking space, and confronted Blanton and Grigg; who were campaigning against Rodney Fitch, Robert Queen, Joel Shores, Ron Humphries, and Greg Taylor. Allegedly after Fitch had words with Blanton and Grigg he went inside the library and demanded loudly to see the Library's security camera footage. It is alleged that people inside the library were severely frightened by "a man yelling and screaming and carrying a gun while inside the library." The Shelby Police were eventually called. Nothing official was ever done about this that **Robert A** knows of. But, by all accounts, Rodney Fitch's campaign signs were found to have been moved by Election Board officials because they violated some kind of "distance" violation. Fitch's signs were returned to him. Robert A published an account of this alleged incident a few days later and since Robert A had not personally witnessed this incident himself, Robert A clearly indicated that all reports or this incident were "gossip."
- Now, it is several weeks after the 2024 CCS School Board Primary Elections and <u>Robert A</u> personally observed that Rodney Fitch was absent from the March 11, 2024 and the April 8, 2024 Official School Board scheduled meetings. <u>Robert A</u> also personally observed that School Board

Member Walter Scott Spurling has moved into Rodney Fitch's "empty seat" during the past two official school board meetings (March 11 and April 8, 2024). The "gossip" going around is that Rodney Fitch has been banned from School Board meetings and CCS property because of the items noted above or some other unknown reason. "Gossip" also reports that Walter Scott Spurling's moving into Rodney Fitch's empty seat is to make more space between himself and Danny Blanton, whom Spurling appears to have been ordered by Chairman Robert Queen to harass Blanton during School Board meetings. Robert A has personally observed Spurling harassing Blanton during school board meetings and Spurling moving away from Blanton during both the March 11 and April 8, 2024 School Board Meetings when, Rodney Fitch was absent. The School Board going into CLOSED SESSION with their lawyer to discuss "Personnel Matters" at these two meetings when Rodney Fitch was absent could easily have included potential disciplinary actions (such as censure or removal) against Rodney Fitch as they did back last May, 2023 against Danny Blanton and Ronnie Grigg for exercising their First Amendment Rights regarding the vandalism at Burns High School and the subsequent coverup.

Now folks, I have said all that to say this: <u>Rodney Fitch</u> came to see <u>Robert A</u> at home this past Friday, April 19, 2024 at around 1:00 PM. Rodney Fitch had just read my last article published that very day regarding the School Board (minus Rodney Fitch who was absent) voting to approve fabricated and false legal documents. And the gossip report that Rodney Fitch was somehow removed from the CCS School Board. Rodney Fitch was as mad as an old wet hen!
