

Cleveland County is Broke, Now CC School Board is Broke too???!!!

Report, facts, calculations, Conclusions, eritas and informed opinions by Robert A

Folks, the entire Cleveland County School Board will hear some bad news at their next School Board Meeting, this evening. At 6:00PM January 13, 2025. The CCS Finance Committee Report will contain information that Cleveland County has been reclassified by the State of North Carolina as being a **Tier 1 County**, For YOUR convenience the particular paragraph of that report says:

“Dr. Fisher shared that the Cleveland County tier status has changed to move us back to a *Tier I county*. This annual designation is based on the economic well-being of each county with the 40 most distressed counties being designated Tier 1.

Tier status is determined by four factors:

- **average unemployment rate,**
- **median household income,**
- **percentage growth in populationand**
- **adjusted property tax baseper capita.**

As a result, *Cleveland County is designated a Tier 1 county for 2025.*”

Folks, If you don't understand these words above, think of it as this:

The State of North Carolina has decided to select the economically WORST 40 Counties in North Carolina and Cleveland County is one of them. In other words, despite what the CCS School Board and the Cleveland County Commissioners tell us, Cleveland County is on the BOTTOM 40 of the 100 counties in North Carolina. The only question that remains is: ARE we on the bottom of the bottom 40? Or, are WE *near the top* of the bottom??? Either way, if we are not on the bottom, we are near enough to the bottom to see it from here.

Also, it is clear that at least 60 Counties in North Carolina are much better off and much better led than Cleveland County. Economically!! And Education wise too. If YOU are a business looking to settle in North Carolina, where would YOU Choose to Go??? Certainly NOT to Cleveland County.

Also, Part 2. There was nothing else in the Report that will be read tomorrow night related to Cleveland County's FAILING Education System as related to where Cleveland County Stands economically! WE ALL know the two things are directly related. The better the education, the better we are economically!

We also ALL KNOW that the Superintendent of a School District is responsible for providing the students of Cleveland County the opportunity of a "sound basic education."

We also know that the District's SCHOOL BOARD is responsible for seeing to it that the Superintendent, Stephen Fisher, has NOT been able to keep Cleveland County Schools OFF the BOTTOM

of all of these bad lists.

When this “Report” from the Finance Committee is read off tomorrow night, Robert A recommends the School Board to immediately remove Dr. Stephen Fisher from his position as CCS Superintendent and appoint another as the Interim Superintendent.

Then, School Board members: Joel Shores, Ron Humphries, Walter Scott Spurling, Gloria Sherman and Aaron Bridges should all RESIGN IMMEDIAELY.

Lincoln County. Right Next Door to Cleveland County, was Number 24!!

According to the BEST 30 Report, Lincoln County has:

- life expectancy at birth: 77.0 years
- Poverty rate: 3%
- Adults with a bachelor's degree:1%
- Median household income:\$75,672
- Population:87,933

Note that the Lincoln County Median Household income is almost twice that of Cleveland County. That is about all that you need to know about why Lincoln County is WAY so much better than Cleveland County.
