CC Commissioners Approve New FY 25-26 Budget on a 3-2 Split Vote!

Editor's Note: The tension at the June 3, 2025 CC Commissioners Meeting was so thick it had to almost be cut through with a "Chainsaw." Kevin Gordon, Johnny Hutchins and Doug Bridges voted to approve the Budget and Tony Berry and Deb Hardin voted against the Budget.

Tony Berry then gave his valid reasons for voting against the new Budget.

When the meeting was adjourned, two Sheriff's Department Deputies came up to the front of the meeting room to prevent citizens from interacting with the CC Commissioners.
